

RESOLUTION NO. R-2012-11

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING AND APPROVING AN AMENDMENT TO THE BUILDING FEE SCHEDULE TO ADJUST RE-OCCUPANCY FEES FOR THE CITY DEPARTMENT OF COMMUNITY PLANNING AND DEVELOPMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") requires a Certificate of Re-occupancy each time there is any transfer of ownership of a residential building, whether single-family, duplex, triplex condominium or apartment, to ensure that structures originally built for residential use are still utilized for that purpose and are in compliance with the requirements of the Land Development Regulations and the City's building and life safety codes; and

WHEREAS, both the seller and the buyer are responsible for obtaining a Certificate of Re-occupancy, upon completion of an inspection conducted by City building inspectors; and

WHEREAS, on May 26, 2009 the City adopted a Building Fee Schedule by Resolution R-2009-83 to reflect all building related fees including Certificate of Re-occupancy which was previously established by Ordinance; and

WHEREAS, the required inspection for the issuance of a Certificate of Re-occupancy is taking an enormous amount of staff time and resources, especially as they relate to larger multi-family residential buildings; and

WHEREAS, despite budgetary shortfalls and increased costs, the current fee structure relative to re-occupancy certificates has not changed since the year 2001; and

WHEREAS, the Department of Community Planning and Development is proposing to make several adjustments to the Building Fee Schedule, in order to offset expenses incurred in the inspections and issuance of Certificates of Re-occupancy; and


WHEREAS, the Mayor and City Council find that the proposed fee schedule, attached hereto as "Exhibit A", is fair and reasonable and essential for the continued provision of the Certificate of Re-occupancy program, focusing on the public's health, safety and welfare.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Adoption of New Fee Schedule. The Mayor and City Council of the City of North Miami, Florida, hereby authorize and approve an amendment to the Building Fee Schedule to adjust re-occupancy fees for the City Department of Community Planning and Development, attached hereto as "Exhibit A".

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.


