

RESOLUTION NO. R-2012-17

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A TWO-YEAR CONTRACT WITH PORT CONSOLIDATED, INC., FOR THE PURCHASE AND DELIVERY OF GASOLINE AND DIESEL FUEL FOR CITY OWNED VEHICLES, IN THE AMOUNT OF ONE MILLION NINE HUNDRED FORTY THOUSAND FOUR HUNDRED DOLLARS AND NO CENTS (\$1,940,400.00), IN ACCORDANCE WITH THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING COOPERATIVE GROUP - RFP NUMBER 09-A-149, IN ORDER TO MAINTAIN THE UNINTERRUPTED SUPPLY AND DELIVERY OF MOTOR FUEL TO THE CITY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on January 1, 2010, the City of North Miami ("City") entered into a two-year piggyback agreement under the Southeast Florida Governmental Purchasing Cooperative Group for the purchase and delivery of gasoline and diesel fuel for City vehicles; and

WHEREAS, on March 22, 2011, the Mayor and City Council passed and adopted Resolution No. R-2011-31, authorizing the City Manager to expend Seven Hundred Thousand Dollars and No Cents (\$700,000.00) to cover the increased costs of fuel purchases and deliveries, through the end of the fiscal year; and

WHEREAS, City Administration desires to secure vital deliveries and supplies of unleaded gasoline and diesel fuel at a competitive price, by entering into a two-year contract through the Southeast Florida Governmental Purchasing Cooperative Group, in order to continue to provide essential City services; and

WHEREAS, the Mayor and City Council of the City of North Miami, have determined a two-year contract securing the City's supply of motor fuels in the amount of One Million Nine Hundred Forty Thousand Four Hundred Dollars and No Cents (\$1,940,400.00), is in the City's best interest.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to enter into a two-year contract with

Port Consolidated, Inc., for the to the purchase and delivery of gasoline and diesel fuel for City owned vehicles, in the amount of One Million Nine Hundred Forty Thousand Four Hundred Dollars and No Cents (\$1,940,400.00), in accordance with the Southeast Florida Governmental Purchasing Cooperative Group - RFP Number 09-A-149, in order to maintain the uninterrupted supply and delivery of motor fuel to the City.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
