

RESOLUTION NO. R-2012-43

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A THIRD AMENDMENT TO THE STATE OF FLORIDA DEPARTMENT OF COMMUNITY AFFAIRS 2005 DISASTER RECOVERY INITIATIVE CDBG GRANT AGREEMENT BETWEEN MIAMI-DADE COUNTY AND THE CITY OF NORTH MIAMI TO PROVIDE FOR AN EXTENSION OF THE CONTRACT PERIOD AND FOR THE RECEIPT AND EXPENDITURE OF GRANT FUNDS IN AN AMOUNT NOT TO EXCEED THREE MILLION SEVEN HUNDRED TWELVE THOUSAND FIVE HUNDRED DOLLARS AND NO CENTS (\$3,712,500.00) FOR HOUSING REHABILITATION PROJECTS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") was initially awarded One Million Five Hundred Ninety Thousand Dollars and No Cents (\$1,590,000.00) under the State of Florida Department of Community Affairs 2005 Disaster Recovery Initiative CDBG Grant to assist low and moderate income families with housing rehabilitation; and

WHEREAS, subsequent to the initial award, the City entered into amendments with the County for "Round Two" of this Disaster Recovery Initiative CDBG Grant to accept additional allocations of Three Million Dollars and No Cents (\$3,000,000.00) and Seven Hundred and Twelve Thousand Five Hundred Dollars and No Cents (\$712,500.00) to assist low and moderate income families with housing rehabilitation; and

WHEREAS, the City has encumbered all the funding and expended more than ninety-five percent (95%) of the funds allocated; and

WHEREAS, the County in recognition of the City's expeditious expenditure of the funds, desires to amend the agreement to disburse the remaining grant funding not to exceed the total amount of this "Round Two" Disaster Recovery Grant funding of Three Million Seven Hundred Twelve Thousand Five Hundred Dollars and No Cents (\$3,712,500.00); and

WHEREAS, the City is required to utilize these funds to repair homes damaged as a result of the 2005 hurricanes; and

WHEREAS, to receive reimbursements of the additional Grant funds the City must execute an amended Agreement with the County which extends the completion date to June 30, 2012; and


WHEREAS, the Mayor and City Council desire to authorize the execution of this amendment to the agreement for the extension of the contract period and the receipt and expenditure of funds for the purpose of housing rehabilitation.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND THE CITY COUNCIL FO THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Authority to City Manager. The City Manager is hereby authorized to execute an amendment to the State of Florida Department of Community Affairs 2005 Disaster Recovery Initiative CDBG Grant Agreement between Miami-Dade County and the City of North Miami to provide for an extension of the contract period and for the receipt and expenditure of grants funds in an amount not to exceed Three Million Seven Hundred Twelve Thousand Five Hundred Dollars and No Cents (\$3,712,500.00) for housing rehabilitation projects.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.

GOVERNMENTAL CONTRACT BETWEEN
MIAMI-DADE COUNTY
AND
THE CITY OF NORTH MIAMI**

This amendment amends the FY 2005 CDBG Contract (the "Contract") entered into between Miami-Dade County, hereinafter referred to as the "County" and The City of North Miami hereinafter referred to as the "Awardee" executed on June 8, 2009, is amended as follows:

IV. The Awardee and the County Agree:

A. Effective Date

2. This Contract shall expire on June 30, 2012. Any costs incurred by the Awardee beyond this date will not be reimbursed by the County. The term of this agreement and the provisions herein may be extended by the County to cover any additional time period during which the Awardee remains in control of the CDBG funds or other assets, including Program Income to support CDBG eligible activities. Any extension made pursuant to this paragraph shall be accomplished by a writing by the County to the Awardee. Such notice shall automatically become a part of this contract.

The effective date of this amendment is December 31, 2011.

This Amendment is intended to extend the Contract, until June 30, 2012. The Parties ratify and adopt all the provisions, duties and obligations of the Contract as if fully set forth herein.

This Amendment and all its attachments are hereby made a part of the Contract. Except for the changes enumerated herein, this agreement shall remain unchanged.
