

RESOLUTION NO. CR-2012-55

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF AN APPLICATION AND FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UNITED STATES DEPARTMENT OF JUSTICE FOR GRANT FUNDS FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Edward Byrne Memorial Justice Assistance Grant (JAG) and Local Law Enforcement Block Grant (LLEBG) have been combined to provide one single source of funding for technical assistance, training, personnel, equipment, supplies, contractual support and information systems for criminal justice to prevent and control crime; and

WHEREAS, the City of North Miami ("City") has received an allocation in the amount of Forty-Four Thousand Four Hundred Ninety Dollars (\$44,490.00), with no required match, to assist the City with this purpose; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the United States Department of Justice for the purpose of securing grant funds.

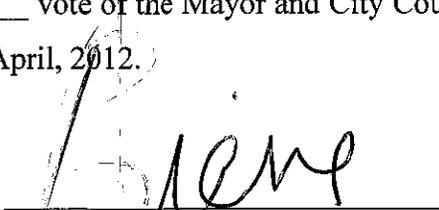
NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority to Submit Application. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submission of an application to the United States Department of Justice for the Edward Byrne Memorial Justice Assistance Grant (JAG) and Local Law Enforcement Block Grant (LLEBG) in the amount of Forty-Four Thousand Four Hundred Ninety Dollars (\$44,490.00).

Section 2. Authority to City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the United States Department of Justice.

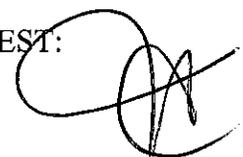
Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.

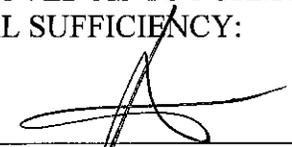
