

RESOLUTION NO. R-2012-72

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING AMENDMENTS TO FISCAL YEARS 2000, 2002, 2003, 2005, 2006, 2007 AND 2008 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ACTION PLANS BY REPROGRAMMING FUNDS FROM GROUNDS IMPROVEMENT PROJECTS TO SINGLE FAMILY HOUSING REHABILITATION; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, since 1994, the City of North Miami (“City”) has received Community Development Block Grant (“CDBG”) funds from the U.S. Department of Housing and Urban Development (“HUD”), in order to provide a source of funding for various community and economic development programs and projects; and

WHEREAS, HUD program regulations require that the City prepares an annual Action Plan in order to receive CDBG funds.

WHEREAS, the City allocated CDBG funds in Fiscal Years 2000, 2002, 2003, 2005, 2006, 2007 and 2008 to Program Administration; and

WHEREAS, the City also allocated CDBG funds in Fiscal Year 2008 to Multi-Family Rehabilitation; and

WHEREAS, Resolutions R-2011-71 and R-2011-106 reprogrammed unspent funds from the Program Administration and Multi-Family Rehabilitation allocations to Single Family Rehabilitation and Grounds Improvement in order to better utilize the funds; and

WHEREAS, in order to address the demand in the community and to improve the quality of low and moderate income neighborhoods, the City desires additional funding of Single Family Housing Rehabilitation Projects; and


WHEREAS, the Mayor and Council wish to reprogram those funds previously allocated in 2011 to Grounds Improvement Projects, in the amount of One Hundred Seventy-Eight Thousand Dollars (\$178,000.00) to Single Family Housing Rehabilitation; and

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Approval of CDBG Action Plan Amendments. The Mayor and City Council of the City of North Miami, Florida, hereby approve the amendments to Fiscal Years 2000, 2002, 2003, 2005, 2006, 2007 and 2008 Community Development Block Grant (CDBG) Action Plans by reprogramming One Hundred Seventy-Eight Thousand Dollars (\$178,000.00) from Grounds Improvement Projects to Single Family Housing Rehabilitation.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.


