

**RESOLUTION NO.     R-2012-79**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING THE FISCAL YEAR 2011-2012 ADOPTED AMENDED REVENUE AND EXPENSE BUDGETS, TO INCLUDE THE RECEIPT AND APPROPRIATION OF GRANT FUNDS FROM THE FLORIDA BAR IN THE AMOUNT OF FIVE THOUSAND DOLLARS (\$5,000.00) FOR SUMMER LEGAL INTERNSHIP PROGRAMS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) applied to obtain grant funds from the City, County, and Local Government Law Section of the Florida Bar (“Florida Bar”), to support a local-student internship program with the Office of the City Attorney (“Internship”); and

**WHEREAS**, the Florida Bar approved and selected the City’s application, awarding a grant in the amount of Five Thousand Dollars (\$5,000.00) to fund the Internship; and

**WHEREAS**, the grant funds will provide valuable experience in the specialized area of local government law for two (2) summer Internships over a ten-week period; and

**WHEREAS**, the Mayor and City Council passed and adopted an annual budget in accordance with the City Charter for the current Fiscal Year 2011-2012, commencing October 1, 2011; and


**WHEREAS**, City administration respectfully requests the approval of the proposed amendment to the Fiscal Year 2011-2012 Revenue and Expense Budgets to recognize the receipt and appropriation of the forementioned Florida Bar grant funds, in order to maintain the legal Internship programs during the summer.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Amendment of Budget.** The Mayor and City Council of the City of North Miami, Florida, hereby amend the Fiscal Year 2011-2012 adopted amended Revenue and Expense Budgets, to include the receipt and appropriation of grant funds from the Florida Bar in the amount of Five Thousand Dollars (\$5,000.00) for summer legal internship programs.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
