

RESOLUTION NO. R-2012-88

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR A GRANT FROM THE OCCUPANT PROTECTION AND CHILD SAFETY PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of applying for and securing a grant from the Florida Department of Transportation's Occupant Protection and Child Safety Program; and

WHEREAS, the City of North Miami has submitted a concept paper for a project in the amount of Twenty-Nine Thousand Eight Hundred Dollars (\$29,800.00) with an in-kind match in the amount of Fifteen Thousand Nine Hundred Fifty-Six Dollars (\$15,956.00) for a total project cost of Forty-Five Thousand Seven Hundred Fifty-Six Dollars (\$45,756.00); and

WHEREAS, funds will be used toward seat belt enforcement patrols and educational sessions focused on the importance of seat belt protection; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the Florida Department of Transportation for the purpose of securing grant funds.


NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Submittal of Application. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submittal of the City of North Miami's application for a grant from the Florida Department of Transportation's Occupant Protection and Child Safety Program.



PASSED AND ADOPTED by a 4-0 vote of the Mayor and City Council of the City of North Miami, Florida, this 10 day of July, 2012.


