

**RESOLUTION NO. R-2012-94**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DESIGNATING NW 11<sup>TH</sup> AVENUE FROM 119<sup>TH</sup> STREET TO 135<sup>TH</sup> STREET TO BE KNOWN AS "COMMISSIONER JEAN MONESTIME AVENUE"; AUTHORIZING THE CITY MANAGER TO ALLOCATE AND EXPEND THE NECESSARY FUNDS TO COVER THE COSTS FOR SIGNAGE, AND DO ALL NECESSARY THINGS TO EFFECTUATE THE DESIGNATION; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, Commissioner Jean Monestime has been a resident and business owner for many years in the City of North Miami ("City") and has resided in Miami-Dade County for over thirty (30) years; and

**WHEREAS**, Commissioner Jean Monestime has served as a former Councilman and Vice-Mayor for the City; and

**WHEREAS**, Commissioner Jean Monestime has served on the North Miami Mayor's Economic Task Force and the North Miami Community Redevelopment Agency, and was nominated for the Greater North Miami Chamber of Commerce Quality of Life Improvement Award; and

**WHEREAS**, Commissioner Jean Monestime became the first Haitian-American to serve as a Miami-Dade County Commissioner for District 2, which includes the City of North Miami; and

**WHEREAS**, in recognition of his continuing dedication and commitment to the City and its residents, the Mayor and City Council wish to designate NW 11<sup>th</sup> Avenue from 119<sup>th</sup> Street to 135<sup>th</sup> Street, as "COMMISSIONER JEAN MONESTIME AVENUE"; and

**WHEREAS**, the Mayor and City Council desire to authorize the City Manager to allocate and expend the necessary funds to cover the costs if any and effectuate the designation of said avenue as "COMMISSIONER JEAN MONESTIME AVENUE."




**Section 1. Approval of Street Designation.** The Mayor and City Council of the City of North Miami, Florida, hereby designate NW 11<sup>th</sup> Avenue from 119<sup>th</sup> Street to 135<sup>th</sup> Street to be known as "COMMISSIONER JEAN MONESTIME AVENUE."


