

RESOLUTION NO. 2014-R-82

A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING AN AMENDMENT TO THE FISCAL YEAR 2013-14 AMENDED REVENUE AND EXPENSE BUDGET TO INCLUDE THE RECEIPT AND APPROPRIATION FOR A PUBLIC LIBRARY CONSTRUCTION GRANT FROM THE FLORIDA DEPARTMENT OF STATE, DIVISION OF LIBRARY AND INFORMATION SERVICES, IN THE AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES

WHEREAS, the Vice Mayor as Acting Mayor and City Council passed and adopted an annual budget in accordance with the Charter of the City of North Miami ("City") for the Fiscal Year commencing October 1, 2013; and

WHEREAS, on June 11, 2013, the Mayor and City Council approved Resolution R-2013-61, approving the application for a Public Library Construction Grant from the Florida Department of State, Division of Library and Information Services; and

WHEREAS, the City was awarded the Grant in the total amount of Five Hundred Thousand Dollars (\$500,000.00); and

WHEREAS, in accordance with Resolution R-2013-61, City Administration amended the Fiscal Year 2013-2014 Amended Revenue and Expense Budget to reflect receipt of the awarded funds; and

WHEREAS, City Administration recommends ratifying the amendment of Fiscal Year 2013-2014 Amended Revenue and Expense Budget to recognize these new grant funds as revenue and enable the increase in appropriation for the corresponding expenditures; and

WHEREAS, the Vice Mayor as Acting Mayor and City Council wish to amend the Fiscal Year 2013-2014 Amended Revenue and Expense Budget accordingly.

NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Amendment of Budget. The Vice Mayor as Acting Mayor and City Council hereby amend the Fiscal Year 2013-2014 Amended Revenue and Expense Budget to include the receipt and appropriations for the grant funds in the total amount of Five Hundred Thousand Dollars (\$500,000.00), for the library construction project.


Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
