

RESOLUTION NO. 2018-R-27

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND R.J. BEHAR & COMPANY, INC., TO ADD CONSTRUCTION ADMINISTRATION SERVICES, AT A COST NOT TO EXCEED FIFTY-THREE THOUSAND FIFTEEN DOLLARS (\$53,015.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, on January 26, 2017, the City of North Miami (“City”) entered into an Continuing Architectural & Engineering Services Agreement with R.J. Behar & Company, Inc. (“Consultant”), to provide the City with Water Resources and Stormwater Design Services for the Tressler Street Drainage Improvements Project, in accordance with the technical specifications, terms, and conditions contained in the *Request for Qualifications #12-14-15, Continuing Architectural & Engineering Services* (“RFQ”); and

**WHEREAS**, the City desires to amend the Agreement to include construction administration services during the construction phase due to the complexity of the project and Consultant’s knowledge of the project (“Additional Services”); and

**WHEREAS**, Additional Services will include: conducting progress meetings, construction observation and project schedule reports, materials testing during construction and providing record drawings; and

**WHEREAS**, the Additional Services can be obtained by amending the Agreement at a cost not to exceed Fifty-Three Thousand Fifteen Dollars (\$53,015.00); and

**WHEREAS**, the City Administration respectfully requests that the Mayor and City Council authorize an amendment to the Agreement to attain Additional Services for the aforementioned reasons, benefiting the City.


**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney


to negotiate and execute an amendment to the agreement between the City of North Miami and R.J. Behar, Inc., to include construction administration services, at a cost not to exceed Fifty-Three Thousand Fifteen Dollars (\$53,015.00).

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
