

RESOLUTION NO. 2018-R-7

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF CEEPCO CONTRACTING, LLC, AS THE LOWEST, RESPONSIVE AND RESPONSIBLE CONTRACTOR TO PERFORM THE ROADWAY IMPROVEMENTS PROJECT ON N.E. 133 STREET FROM WEST DIXIE HIGHWAY TO N.E. 11<sup>TH</sup> AVENUE, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 11-17-18 – ROADWAY IMPROVEMENTS PROJECT – N.E. 133<sup>RD</sup> STREET; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH CEEPCO CONTRACTING, LLC, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED THIRTY-EIGHT THOUSAND FOUR HUNDRED FORTY-SIX DOLLARS AND EIGHTY-SEVEN CENTS (\$438,446.87); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

WHEREAS, on November 30, 2017, the City of North Miami (“City”) advertised *Invitation for Bid No. 11-17-18 – Roadway Improvements Project – N.E. 133<sup>rd</sup> Street* (“IFB”), soliciting qualifications from experienced and qualified contractors to perform a roadway improvements project along N.E. 133 Street between West Dixie Highway and N.E. 11<sup>th</sup> Avenue; and

WHEREAS, pursuant to the IFB, the selected contractor is required to provide all necessary labor, equipment, materials and expertise required for the implementation and completion of the roadway improvements project including, but not limited to: milling and resurfacing on N.E. 133 Street from W. Dixie Highway to 11<sup>th</sup> Avenue, addition of curbs, gutters and on-street parking as well as installation of new streetlights and drainage structures consisting of exfiltration trench, trench drain and catch basins (“Services”); and

WHEREAS, in response to the IFB, the City received and opened twelve (12) bids and Ceepco Contracting, LLC (“Contractor”), was determined to be the lowest responsive and responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, in accordance with City administration’s ranking, the City Manager respectfully requests that the Mayor and City Council approve the selection of the Contractor, as

the lowest, responsive-responsible bidder in the provision of Services, and authorize the City Manager and City Attorney to negotiate and execute an agreement at a cost not to exceed Four Hundred Thirty-Eight Thousand Four Hundred Forty-Six Dollars and Eighty-Seven Cents (\$438,446.87); and

**WHEREAS**, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of Contractor and hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services to perform the roadway improvements project.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**     **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City administration's ranking and selection of CEEPCO Contracting, LLC, as the lowest, responsive and responsible contractor to perform the roadway improvements project on N.E. 133 Street between West Dixie Highway and N.E. 11<sup>th</sup> Avenue, in accordance with the terms, conditions and specifications contained in *IFB No. 11-17-18 – Roadway Improvements Project – N.E. 133<sup>rd</sup> Street.*

**Section 2.**     **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services with CEEPCO Contracting, LLC, at a cost not to exceed Four Hundred Thirty-Eight Thousand Four Hundred Forty-Six Dollars and Eighty-Seven Cents (\$438,446.87).

**Section 3.**     **Effective Date.** This Resolution shall become effective immediately upon adoption.
