This is the first time the Foundation is participating in Give Miami Day, which is a *giving* event managed by The Miami Foundation and allows individuals in our community to make a charitable gift to a local nonprofit, such as the North Miami Educational Foundation. Besides, this event affords the NMEFI the opportunity to be eligible for *bonus* dollars for all donations over \$25.00.

Since its inception in 2012, the Foundation has administered a scholarship program, the only one of its kind throughout Miami-Dade County available exclusively to North Miami residents, and has awarded \$50,000 in scholarships to 14 high school graduates. In addition, these students can qualify for additional grants for each year they remain in college (up to four years) as fulltime students. The scholarships are offered once a year and criteria is posted on the city of North Miami's website at [NorthMiamiFL.gov](http://www.northmiamifl.gov/residents/students.aspx/) throughout the year: <http://www.northmiamifl.gov/residents/students.aspx/>.
