WHEREAS, Section 163.400 of the Florida Statutes encourages municipalities to do any all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

WHEREAS, the Mayor and City Council wish to approve the Interlocal Services Agreement relating to the provision of indirect services by the City to the NMCRA, in substantially the form attached as Exhibit "A."

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

<u>Section 1.</u> <u>Authority of City Manager.</u> The City Manager is authorized to execute an Interlocal Services Agreement, in substantially the attached form, between the City of North Miami and the North Miami Community Redevelopment Agency for the provision of indirect services by the City to the NMCRA for Fiscal Year 2020-2021.
