

RESOLUTION NO. 2021-R-38

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF GREENWISE GROUP, LLC AS THE NEXT LOWEST RESPONSIVE AND RESPONSIBLE BIDDER FOR TREE TRIMMING SERVICES IN ACCORDANCE WITH SECTION 7-137(I)(4) OF THE CODE OF ORDINANCES AND THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BIDS NO. 36-18-19; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on January 14, 2020, the Mayor and City Council awarded a contract to Sherlock Tree Company, Inc., as the lowest responsive and responsible bidder in response to *Invitation for Bids (IFB) No. 36-18-19 - Tree Trimming Services* to provide the tree trimming services throughout City of North Miami (“City”) rights-of-ways; and

**WHEREAS**, Sherlock Tree Company, Inc. informed staff that they can no longer perform the services required under the contract for the prices quoted in their bid proposal and has discontinued their services to the City; and

**WHEREAS**, the City has terminated its agreement with Sherlock Tree Company and is desirous of replacing them with another contractor; and

**WHEREAS**, in accordance with section 7-137(h)(4) of the City Code, if the contract is terminated, the City may elect to award the contract to the next lowest responsive and responsible bidder if it is in the best interest of the City to award based upon the bids submitted rather than re-bid and the next lowest responsive and responsible bidder agrees, in writing, to the extension of the bid for the additional period of time; and

**WHEREAS**, the next lowest responsive and responsible bidder, Green Wise Group, LLC, has agreed in writing to honor their pricing as submitted in their original bid proposal; and

**WHEREAS**, to ensure the continuation of these essential services without disruption and to make certain that there are not unnecessary delays as expected with engaging in a new

solicitation process, City staff recommends proceeding with Green Wise Group, as the next lowest, responsive and responsible bidder; and

**WHEREAS**, the Mayor and City Council find that it is in the best interest of the City to award based upon the bids submitted rather than re-bid and hereby approve the selection of Vendor and authorize the negotiation and execution of an agreement for the provision of Services.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's selection of Green Wise Group, LLC, as the next lowest responsive and responsible bidder to provide leasing, tree trimming services in accordance with section 7-137(I)(4) and the terms and conditions contained in *Invitation for Bids (IFB) No. 36-18-19 - Tree Trimming Services*.

**Section 2. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with Green Wise Group, LLC.

**Section 3. Effective Date.** This Resolution shall be effective immediately upon adoption.
