The City of North Miami has been notified that it will receive a total of \$1,089,029 in federal funds comprised of a Community Development Block Grant (“CDBG”) allocation of \$788,498 and a Home Investment Partnerships Program (“HOME”) grant allocation of \$300,531 for FY 2021-2022. **On May 13, 2021, the city was notified of a CDBG grant increase in the amount of \$11,620.00 making the total FY 2021-2022 (“CDBG”) funds to be received \$800,118. The total federal funds to be received will increase to \$ 1,100,649. The additional funds will be applied towards the (“CDBG”) Housing Rehabilitation Activity. See chart below.** The federal grants will be used to develop stronger communities by providing decent housing, creating suitable living environment, and expanding economic opportunities, principally for people of low- to moderate-incomes. The Annual Action Plan sets priorities among the needs identified in the 5-year approved Consolidated Plan and sets out the plan for use of the funds on a yearly basis. The Plan will be submitted to the U.S. Department of Housing and Urban Development (“HUD”) on or before August 15, 2021. The projected use of funds are provided below:
