

RESOLUTION NO. 2021-R-78

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING CLINTON BOWER TO THE NUISANCE ABATEMENT BOARD, IN ACCORDANCE WITH CHAPTER 12, ARTICLE 10, SECTION 12-50, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, the Nuisance Abatement Board serves as a quasi-judicial forum in which controversies over the existence of public nuisances may be resolved in the public interest while according due process of law; and

**WHEREAS**, Chapter 12, Article 10, Section 12-50, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Nuisance Abatement Board; and

**WHEREAS**, the Nuisance Abatement Board shall consist of five (5) individuals whose residences are located within the city and/or who own businesses within the city and who are appointed by the city council., in accordance with Section 12-50(a)(1) of the City Code; and

**WHEREAS**, Councilman Scott Galvin desires to appoint Clinton Bower to the Nuisance Abatement Board.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**     **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.


**Section 2.**     **Appointment.** Councilman Scott Galvin of the City of North Miami, Florida, hereby appoints Clinton Bower to the Nuisance Abatement Board.

**Section 3.**     **Effective Date.** This Resolution shall become effective immediately upon adoption.
