

RESOLUTION NO. 2021-R-77

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING HEGEL LAURENT, ESQ. TO GROUP B OF THE PERSONNEL BOARD, IN ACCORDANCE WITH CHAPTER 15, ARTICLE I, SECTION 15-4, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Personnel Board hears appeals of employees in the classified service who are suspended, reduced or removed and reports its findings and recommendations to the City Manager and also reviews the activities of the personnel department and makes recommendations; and

WHEREAS, in accordance with Chapter 15, Article I, Section 15-4, of the City of North Miami Code of Ordinances, appointment to Group B shall be made by one (1) member by the city council (excluding the mayor); and

WHEREAS, the Personnel Board shall consist of six (6) members who shall be qualified voters of the city and shall be known to be in sympathy with the merit principle as applied to the civil service; and

WHEREAS, Councilwoman Mary Estimé-Irvin desires to re-appoint Hegel Laurent, Esq. to Group B of the Personnel Board.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.


Section 2. **Appointment.** Councilwoman Mary Estimé-Irvin of the City of North Miami, Florida, hereby re-appoints Hegel Laurent, Esq. to Group B of the Personnel Board.

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
