## RESOLUTION NO. 2021-R-67

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING FISCAL YEAR 2021-2022 ANNUAL ACTION PLAN UNDER THE CDBGAND HOME PROGRAMS; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") has been designated as an "Entitlement Community" and therefore receives direct annual funding from the U.S. Department of Housing and Urban Development ("HUD") for Community Development Block Grant ("CDBG") and Home Investment Partnerships Program ("HOME") programs; and

**WHEREAS**, since 1994, the City has received CDBG funds from HUD to provide a source of funding for various community and economic development programs and projects; and

WHEREAS, since 2003, the City has received HOME funds to provide a source of funding for community housing programs in accordance with Chapter 420, Part V, Florida Statutes, as amended from time to time; and

WHEREAS, the City will receive Eight Hundred Thousand One Hundred Eighteen Dollars (\$800,118.00), and Three Hundred Thousand Five Hundred Thirty-One Dollars (\$300,531.00) in CDBG and HOME funds, respectively, for fiscal year ("FY") 2021-2022; and

WHEREAS, HUD program regulations require that the City prepare an annual Action Plan for the use of grant funds with input from the public; and

**WHEREAS**, on April 15, 2021, the City conducted a virtual public meeting, soliciting public views and input in the development of the Action Plan; and

WHEREAS, in accordance with HUD regulations, the City administration prepared the FY 2021-2022 Action Plan for the use of CDBG and HOME funds; and

WHEREAS, on May 4, 2021, the Planning Commission, after a duly noticed public meeting, found the proposed annual Action Plan to be acceptable and beneficial to the City, and thereby recommended approval to the Mayor and City Council; and

WHEREAS, the Mayor and City Council, after a duly noticed public meeting, concur with the findings of the Planning Commission and find the approval of the attached Action Plan will enhance the public's health, safety and welfare.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA THAT:

<u>Section 1.</u> <u>Approval.</u> The Mayor and City Council of the City of North Miami, Florida, hereby approve Fiscal Year 2021-2022 Annual Action Plan under the CDBG and HOME programs, attached hereto as "Exhibit 1."

<u>Section 2.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
