

RESOLUTION NO. 2021-R-62

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EVALUATION COMMITTEE'S RESULTS AND THE SELECTION OF CENTRALSQUARE TECHNOLOGIES, LLC, FOR FALSE ALARM ADMINISTRATION SERVICES IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN RFP #26-20-21; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED VENDOR; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on February 11, 2021, the City of North Miami ("City") issued *Request for Proposals (RFP) No. 26-20-21 False Alarm Administration Services* ("RFP") seeking proposals from seeking proposals from experienced and qualified firms to provide False Alarm Administration Services in accordance with the terms and conditions of the City's Code of Ordinances. ("Services"); and

WHEREAS, a total of two (2) firms submitted proposals in response to the RFP and were interviewed by the City's Evaluation Committee; and

WHEREAS, CentralSquare Technologies, LLC ("Contractor") was found to be the top ranked firm based on the results of the City's Evaluation Committee, demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the scope of services to be provided include all aspects of false alarm education to our residents and business owners, billing and fee collections, administrative services, appeals and delinquent collections for the Code Compliance Department; and

WHEREAS, services will be provided on a revenue share percentage, with Contractor retaining twenty-five percent (25%) of false alarm fines and fees collected; and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of Contractor.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Selection of Contractor. The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of CentralSquare Technologies, LLC, for False Alarm Administration services in accordance with the terms, conditions and specifications contained in RFP #26-20-21 and the Contractor's proposal submitted in response thereto.


Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with CentralSquare Technologies, LLC for the provision of services and contract award for an initial term of three (3) years and the option to renew for three (3) additional one-year renewal periods, with the approval of the City Manager or duly authorized designee.

Section 3. Effective Date. This Resolution shall be effective upon adoption.
