

**RESOLUTION NO. 2021-R-59**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UNITED STATES DEPARTMENT OF JUSTICE TO SECURE A GRANT FROM THE EDWARD BYRNE JUSTICE ASSISTANCE GRANT PROGRAM FOR FUNDS TO ENHANCE THE ELECTRONIC TICKET WRITER PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and Council of the City of North Miami (“City”) are desirous of securing a grant from the United States Department of Justice (“DOJ”); and

**WHEREAS**, the City will request funds in the amount of Five Thousand Seventy-Eight Dollars (\$5,078.00) with no required match; and

**WHEREAS**, the funds will be used to purchase eight (8) handheld ticket writer printers and car adapters to improve the overall efficiency of the Records Section in the North Miami Police Department; and

**WHEREAS**, the Electronic Ticket Writer Enhancement Program has positively impacted records management within the North Miami Police Department resulting in a substantial error reduction; and

**WHEREAS**, the Mayor and City Council wish to approve the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the DOJ.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification of Submission of Application.** The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submission of the City of North Miami’s application for the Electronic Ticket Writer Enhancement Program Grant.


**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the DOJ, to obtain grant funds.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
