**Important Information About  
Making a Claim for Settlement Relief**

**I. HOW TO MAKE A CLAIM FOR SETTLEMENT RELIEF**

**A. ELIGIBILITY FOR RELIEF**

An account holder of the City of North Miami for water and sewer utility services for a multi-family unit complex on a single or master-meter for the period of December 17, 2016 through the present may be eligible for a credit on the account holder's water and sewer utility services account ("Settlement Relief").

**B. SETTLEMENT RELIEF**

This form pertains to the class action settlement in *The Jockey Club Condominium Apartments, Inc., on behalf of itself and all others similarly situated, v. The City of North Miami*, Miami-Dade County Circuit Case No. 20-27233. You may only submit a Claim if you are a member of the Settlement Class, defined as:

For the period from December 17, 2016 through the date of entry of judgment herein (the "Class Period"), each account holder of the City of North Miami water and sewer utility with multi-family units on a single or master-meter.

The eligible Settlement Class will receive the Settlement Relief, which is comprised of a credit equal to sixty-five percent (65%) of the difference between the City of North Miami's

calculation of water utility bills under Resolution No. R-2012-52 and how the amounts would be calculated under Ordinance 19-96(d)(3) for the period of December 2016 continuing until the City of North Miami alters, amends, or repeals the ordinance at issue.

To determine the amount for which you are eligible as a member of the Settlement Class, please see the Settlement Website to confirm that information.

**C. INSTRUCTIONS TO SUBMIT YOUR CLAIM**

If you are a member of the Settlement Class and wish to submit a Claim to receive the Settlement Relief, you can submit your Claim online at the Settlement Website, [www.northmiamiwatersettlement.com](http://www.northmiamiwatersettlement.com) or via e-mail to [watersettlement@northmiamifl.gov](mailto:watersettlement@northmiamifl.gov). Claims must be completed and submitted by 11:59 p.m., October 16, 2022 to be timely. Each Settlement Class Member is entitled to submit only one Claim Form per account. If your Claim is complete, timely, and approved by the Claims Administrator for the City of North Miami, you will receive the calculated Settlement Relief. If you do not submit a Claim, you will not be eligible to receive the Settlement Relief, but you will still be bound by the Settlement Agreement and its release unless you exclude yourself.

**D. HOW TO COMPLETE THE CLAIM FORM TO DETERMINE WHAT SETTLEMENT RELIEF, IF ANY, FOR WHICH You ARE ELIGIBLE**

You must completely fill out the Claim Form with the information requested. You may not submit a Claim Form unless you are an eligible member of the Settlement Class. You MUST sign the Claim Form and attest to the information.

**E. REVIEW OF YOUR CLAIM**

Once you timely return your completed Claim Form, your claim will be reviewed by the Claims Administrator for the City of North Miami. Subject to the audit of claims, if your Claim Form is properly completed, affirmed, and verified, and the Claims Administrator for the City of North Miami determines that your claim is valid, you will receive your Settlement Relief, subject to final approval by the Court.

**F. AUDIT OF CLAIM FORMS**

**CLAIMANTS ARE CAUTIONED TO NOT SUBMIT FRAUDULENT CLAIMS AS ALL CLAIMS ARE SUBJECT TO AUDIT.**
