

RESOLUTION NO. 2023-R-63

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING WITH FLOCK GROUP, INC. TO GAIN AWARENESS REGARDING COMMUNITIES TO FACILITATE INVESTIGATIONS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami Police Department (“City”) wishes to enter into a Memorandum of Understanding, attached as Exhibit 1, with Flock Group, Inc. (“Flock”) to access Flock’s technology platform and Flock Safety dashboard (“Flock Services”) for investigative purposes in order to view and search photos and videos recorded by Flock and utilize the software for automatic license plate; and

**WHEREAS**, Flock desires to share such recordings and supplemental data with the City to provide awareness with respect to communities to protect and facilitate investigations; and

**WHEREAS**, the Mayor and City Council believe that a Memorandum of Understanding agreement for this purpose will benefit the residents of the city and should be entered into with Flock.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.    Approval.** The Mayor and City Council hereby approve this Memorandum of Understanding with Flock.

**Section 2.    Authority of City Manager.** The City Manager and Interim Police Chief are hereby authorized to execute this Memorandum of Understanding.

**Section 3.    Effective Date.** This Resolution shall be effective upon adoption.
