

RESOLUTION NO. 2023-R-62

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF AN INTERAGENCY AGREEMENT AND JOINT DECLARATION BETWEEN THE CITY OF NORTH MIAMI AND THE PANAMA CITY BEACH TO PROVIDE DATA SHARING FOR INVESTIGATIVE PURPOSES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES

WHEREAS, the entering of an interagency agreement between municipalities is authorized by Chapter 23, Florida Statutes, Florida Mutual Aid Act; and

WHEREAS, the City of North Miami and the Panama City Beach are desirous of entering into an Interagency Agreement and Joint Declaration with each other to provide data sharing for investigative purposes in order to routinely receive License Plate Reader (“LPR”) data from the Panama City Beach Police Department to conduct criminal investigations; and

WHEREAS, the Mayor and City Council wish to approve and authorize the execution of an Interagency Agreement with the Panama City Beach and the accompanying Joint Declaration will benefit the residents of the City of North Miami and should be entered into with the Panama City Beach.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. **Approval of Agreement and Joint Declaration.** The City Council hereby approves the Interagency Agreement and Joint Declaration between the City of North Miami and the Panama City Beach attached as “Exhibit 1.”

Section 2. **Authority of City Manager and Interim Police Chief.** The City Manager and the Interim Chief of Police are authorized to execute the Interagency Agreement and Joint Declaration attached as “Exhibit 1” with the Panama City Beach.

Section 3. **Effective Date.** This Resolution will be effective upon adoption.
