

RESOLUTION NO. 2023-R-73

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING JASON A. NIEVES TO THE NORTH MIAMI PARKS AND RECREATION COMMISSION, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 5, SECTION 2-187, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the purpose of the North Miami Parks and Recreation Commission is to: prepare and recommend a comprehensive master plan for the park and recreation services and needs, review and evaluate the parks and recreation department annual budget and capital improvement proposals, serve in a liaison capacity between the public and the city council, and serve as a public relations interface to the general public; and

WHEREAS, Chapter 2, Article III, Division 5, Section 2-187, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint two (2) members to the Parks and Recreation Commission; and

WHEREAS, appointees shall reside in the City of North Miami and shall not be an employee of the city, in accordance with Section 2-186 of the City Code; and

WHEREAS, Mayor Alix Desulme desires to re-appoint Jason A. Nieves to the North Miami Parks and Recreation Commission.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and, are incorporated herein.

Section 2. **Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby re-appoint Jason A. Nieves to the North Miami Parks and Recreation Commission.

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
