

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE AWARD OF ABSOLUTE CONSTRUCTION SERVICES, INC., AS THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, FOR THE DRAINAGE IMPROVEMENTS PROJECT LOCATED ON N.E. 121ST STREET BETWEEN N.E. 10TH AVENUE AND N.E. 11TH AVENUE; FURTHER AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT TO COMPLETE THE PROJECT IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED SEVENTY-FOUR THOUSAND ONE HUNDRED TWENTY-TWO DOLLARS AND TWENTY-THREE CENTS (\$574,122.23), IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 44-23-24; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on May 3, 2024, the City of North Miami (“City”) issued *Invitation for Bid No. 44-23-24 – N.E. 121st Street Drainage Improvements Project* (“IFB”), soliciting bids from experienced and qualified contractors to furnish all labor, equipment, materials and expertise required to complete the Drainage Improvements Project on N.E. 121st Street between N.E. 10th Avenue and N.E. 11th Avenue, in accordance with the terms, conditions and specifications contained in the IFB (“Services”); and

WHEREAS, in response to the IFB, the City received and opened three (3) bids on June 17, 2024; and

WHEREAS, Absolute Construction Services, Inc. (“Contractor”), was determined to be the lowest responsive and responsible bidder, with experience and qualifications demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the scope of work for the project (“Project”) consists of making improvements to the drainage system on N.E. 121st Street between N.E. 10th Avenue and N.E. 11th Avenue; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City for a total project cost not to exceed Five Hundred Seventy-Four Thousand One Hundred Twenty-Two Dollars and Twenty-Three Cents (\$574,122.23); and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the award of Contractor and further authorize an agreement for the completion of Services.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Award Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the award of Absolute Construction Services, Inc., as the lowest responsive and responsible contractor to perform the Drainage Improvements Project on N.E. 121st Street between N.E. 10th Avenue and N.E. 11th Avenue.

Section 2. Authority of Interim City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an agreement to complete the project in an amount not to exceed Five Hundred Seventy-Four Thousand One Hundred Twenty-Two Dollars and Twenty-Three Cents (\$574,122.23), in accordance with the terms, conditions and specifications contained in *Invitation for Bid No. 44-23-24 – N.E. 121st Street Drainage Improvements Project*.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
