

RESOLUTION NO. 2025-R-19

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING KEVIN SEIFRIED AT-LARGE TO THE CHARTER BOARD, TERM ENDING NOVEMBER 03, 2026, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 3, SECTION 2-82, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Charter Board was created for the purpose of reviewing and analyzing the City Charter and recommending to the city council, for its consideration, amendments to the Charter; and

WHEREAS, Chapter 2, Article III, Division 3, Section 2-82, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Charter Board with two (2) additional members being appointed by the city council as a whole; and

WHEREAS, the Charter Board shall consist of seven (7) individuals who shall be residents of the City, in accordance with Section 2-82 of the City Code; and

WHEREAS, Councilman Kevin A. Burns desires to re-appoint Kevin Seifried at-large to the Charter Board.


