

**RESOLUTION NO. 2025-R-18**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING KENNETH EACH TO THE CHARTER BOARD, TERM ENDING NOVEMBER 07, 2028, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 3, SECTION 2-82, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Charter Board was created for the purpose of reviewing and analyzing the City Charter and recommending to the city council, for its consideration, amendments to the Charter; and

**WHEREAS**, Chapter 2, Article III, Division 3, Section 2-82, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Charter Board with two (2) additional members being appointed by the city council as a whole; and

**WHEREAS**, the Charter Board shall consist of seven (7) individuals who shall be residents of the City, in accordance with Section 2-82 of the City Code; and

**WHEREAS**, Councilman Kevin A. Burns desires to re-appoint Kenneth Each to the Charter Board.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Appointment.** The Mayor and City Council of the City of North Miami, Florida, hereby re-appoints Kenneth Each to the Charter Board.

**Section 3.      Effective Date.** This Resolution shall become effective immediately upon adoption.
