

RESOLUTION NO. 2025-R-127

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
APPOINTING RENE AYALA TO THE COMMUNITY
RELATIONS BOARD, TERM ENDING ON NOVEMBER 07,
2028, BY CHAPTER 2, ARTICLE III, DIVISION 4, SECTION
2-158, OF THE CITY OF NORTH MIAMI CODE OF
ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE
AND ALL OTHER PURPOSES.**

WHEREAS, the purpose of the Community Relations Board shall be to assist in the conciliation of community matters to help foster harmony while recognizing and appreciating the diverse nature of the population of the city; and

WHEREAS, Chapter 2, Article III, Division 4, Section 2-158, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Community Relations Board with two (2) additional members being appointed by the city council as a whole; and

WHEREAS, the Community Relations Board shall consist of seven (7) individuals whose membership shall be representative of the various social, racial, religious, linguistic, cultural, and economic groups comprising the population of the city; and

WHEREAS, each member shall be a resident of North Miami, with an outstanding reputation for community pride, interest, integrity, responsibility, and business or professional ability, in accordance with Section 2-158 of the City Code; and

WHEREAS, Councilman Kevin Burns desires to appoint Rene Ayala to the Community Relations Board.


