

**AMENDMENT TO  
2020 CENTENNIAL CENSUS OUTREACH SERVICES  
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND  
SOUTH FLORIDA CONSULTING FIRM, INC.**

**THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT** (“Amendment”) is entered into on \_\_\_\_\_, between the **City of North Miami**, a Florida municipal corporation with a principal address of 776 NE 125<sup>th</sup> Street, North Miami, Florida (“City”), and **South Florida Consulting Firm, Inc.**, a profit corporation registered and authorized to do business under the laws of the State of Florida, having its principal office at 790 NE 155 Street, North Miami Beach, Florida 33162 (“Contractor”). The City and Contractor shall collectively be referred to as the “Parties”.

**RECITALS**

**WHEREAS**, the City and Contractor are parties to a 2020 Centennial Census Outreach Services Agreement; and

**WHEREAS**, the City desires to amend the Agreement to amend the scope of work and the amount of compensation under the terms of the Agreement; and

**WHEREAS**, the Parties desire to enter into this Amendment to reflect the changes as set forth herein.


**NOW THEREFORE**, in consideration of the mutual terms and conditions set forth below, the Parties agree as follows:

1. **ARTICLE I – SCOPE OF SERVICES** is hereby amended to provide for an additional 4 employees based on additional funding and the inclusion of an additional Proposal to be attached as Exhibit “B.”
2. **ARTICLE III – CONSIDERATION AND PAYMENT** is hereby amended to reflect an additional Five Thousand Dollars (\$5,000.00) in compensation for additional service for a total of Fifteen Thousand Dollars (\$15,000.00) due under the contract.
3. All other terms and conditions of the Agreement remain in full force and effect.


